## Audit Findings

### Audit Narrative

### Introduction

The Prison Rape Elimination Act (PREA) onsite audit of Tennessee Children's Home East (TCH East) was conducted September 28-29, 2020. The parent agency for TCH East is Tennessee Children's Home located at 804 Branham Hughes Circle, Spring Hill, TN 37174. The audit was conducted by Robert B. Latham from Birmingham, Alabama, who is a U. S. Department of Justice Certified PREA auditor for juvenile facilities. The auditor conducted the audit as a single auditor with no additional support staff. The facility contacted the auditor regarding the audit and a contract was agreed upon and signed July 24, 2019. There are no known existing conflicts of interest or barriers to completing the audit. This is the first PREA audit for facility.

### Tennessee Children's Home Mission Statement

### Audit Methodology Pre-Onsite Audit Phase

Prior to being onsite, the PREA Coordinator and the auditor had discussions concerning access to the facility and staff, the audit process, logistics for the onsite phase of the audit, and goals and expectations. The PREA Coordinator was very receptive to the audit process and was well informed of the role of the auditor and the expectations during each stage of the PREA audit.

### Notice of Audit Posting and Timeline

The audit notice was posted March 16, 2020 and reposted September 26, 2020 due to rescheduling. The notices were in English and Spanish. The audit notice was posted using a large font and easy-to-read language. The audit notices were placed throughout the facility, in places visible to all residents and staff. Pictures of the posted audit notices were emailed to the auditor on March 16, 2020 and reposted September 26, 2020 for verification. Further verification of their placement was made through observations during the onsite review. The audit notices included a statement regarding confidentiality

of resident and staff correspondence with the auditor. No correspondence was received during any phase of the audit.

**Pre-Audit Questionnaire (PAQ) and Supporting Documentation**

The PAQ and supporting documentation was received February 4, 2020. The PAQ was completed on February 4, 2020. The documentation was received on a flash drive. The documentation was well organized by standard. The auditor reviewed the PAQ, policy, procedures, and supporting documentation. Using the Auditor Compliance Tool and Checklist of Documentation, the auditor formed an issues log and further discussed the documentation with the PREA Coordinator during the week.

Any person, including, but not limited to, any: Physician, osteopathic physician, medical examiner, chiropractor, nurse or hospital personnel engaged in the admission, examination, care or treatment of persons; Any other health or mental health professional; Practitioner who relies solely on spiritual means for healing; School teacher or other school official or personnel; Judge of any court of the state; Social worker, day care center worker, or other professional child care, foster care, residential or institutional worker; Law enforcement officer; Authority figure at a community facility, including any facility used for recreation or social assemblies for educational, religious, social, health or welfare purposes, including, but not limited to, facilities operated at schools, the boy or girl scouts, the YMCA or YWCA, the boys and girls club or church or religious organizations; or
- When is a report required?  
Knowledge or reasonable cause to suspect that a child has been sexually abused, regardless of whether such person knows or believes that the child has sustained any apparent injury as a result of such abuse.
- Where does it go? The local office of the Department of Children’s Services (DCS) or to the judge having juvenile jurisdiction or to the office of the sheriff or the chief law enforcement official of the municipality where the child resides. Each report of known or suspected child sexual abuse occurring in a facility licensed by the department of mental health and substance abuse services, or any hospital, shall also be made to the local law enforcement agency in the jurisdiction where such offense occurred.

## Onsite Audit Phase

### Entrance briefing

An entrance briefing was held with the Facility Director and Case Manager. The agenda for the two days was discussed, The site review was conducted, and the auditor began the audit by interviewing staff and residents.

### Site review

The auditor had access to, and observed, all areas of the facility. The auditor was provided a diagram of the physical plant during the pre-onsite phase of the audit and was thus familiar with the layout of the facility. In addition to the three (3) living units, the auditor reviewed outside recreation, indoor gymnasium, staff offices, lobby, and classrooms. On the first day of the onsite audit the population of the facility was eight (8) juveniles.

### Processes and areas observed

The auditor observed the intake and risk screening to better understand the process. Grievance boxes are accessible to the residents. Grievance forms are available. Writing utensils are available upon request. The grievance boxes are checked daily.

Phones for reporting sexual abuse, sexual harassment or for contacting external crisis intervention services are available through a resident's case manager. The staff conducting the site review described the showering process, pointed out the location of the cameras and PREA posters with telephone numbers for reporting sexual abuse and sexual harassment. The PREA posters are prominently placed in the housing units and the main building. The auditor informally asked residents about reporting and basic information about sexual safety at the facility.

### Specific area observations

Cameras were located throughout the facility. Residents have single rooms with their own bathroom with a shower. Wherever residents were present, the auditor observed staff actively supervising the residents. The auditor observed the facility to be compliant with the 1:8 ratio requirements. Staff supervision and the video surveillance system mitigate blind spots.

### Exit briefing

An exit briefing was held with the Facility Director. The auditor discussed the onsite audit. Some additional documentation for residents interviewed was requested and provided. The documentation provided by the facility, prior to the onsite phase of the audit, did omit some required documentation. Interviews with the staff and residents demonstrated training and education were effective.

Specific areas discussed:

#### 115.315

Staff training for how to conduct cross-gender pat-down searches, and searches of transgender and intersex residents was required. Corrective action has been completed.

#### 115.321

Memorandum of Understanding for Victim Advocacy Services is required. Corrective action has been completed.

#### 115.322

The agency shall publish the investigations policy for allegations of sexual abuse and sexual harassment on its website. Corrective action has been completed.

**115.335**

Specialized training for medical and mental health care staff was required. Corrective action has been completed.

**115.354**

The agency shall establish a method to receive third-party reports of sexual abuse and sexual harassment and shall distribute publicly information on how to report sexual abuse and sexual harassment on behalf of a resident. Corrective action has been completed.

**115.389**

Annual Report shall include a comparison of the current year’s data and corrective actions with those from prior years and shall provide an assessment of the agency’s progress in addressing sexual abuse. (c) The agency’s report shall be approved by the agency head and made readily available to the public through its website or, if it does not have one, through other means. (d) The agency may redact specific material from the reports when publication would present a clear and specific threat to the safety and security of a facility but must indicate the nature of the material redacted. Corrective action has been completed.

## Interviews Logistics

### Location and Privacy

Interviews were held in a conference room. The location provided privacy, was centrally located to minimize disruption of daily activities and programing and provided room for social distancing and air circulation needed for coronavirus precautions.

### Selection Process

Specialized staff were selected based on their respective duties in the facility. Twelve (12) staff, randomly selected from every shift, were interviewed using the random staff interview protocol. Seven (7) residents were interviewed using the random resident interview questionnaire. Target interviews were selected by information provided by the facility and resident interviews. One (1) residents who reported sexual victimization during risk screening was identified. The resident population was eight (8) on the first day of the audit.

## Facility Operations

### Physical Plant Description

Tennessee Children's Home began in 1909 as the Tennessee Orphan Home in Columbia, Tennessee. It was created to meet the needs of the three Scotten children, who had been tragically orphaned. In 1935, the Home purchased the campus of the Branham and Hughes Military Academy and moved to Spring Hill, Tennessee. As with many of the old orphanages, the Home was designed as an institutional facility with central dining, central laundry, dormitory living, and a small farming operation. The approach to childcare was to provide the basic physical needs of children and to offer Christian instruction. The number of children served grew dramatically throughout the decades, and in late 1982, the name was changed to Tennessee Children's Home. The institutional approach was replaced with family oriented group homes. Dormitories were remodeled into single-family homes, with a maximum of eight children in each home. Central dining was replaced with family meals in the group homes. The family groups now individually carry on most activities, such as home devotionals, church attendance, housekeeping, laundry, cooking, and cleanup. In 1988, THC expanded again by merging with West Tennessee Children's Home, followed in 2000 and 2001 by mergers with Happy Hills Youth Ranch near Ashland City, and East Tennessee Christian Services in Knoxville. Since 1909, TCH has cared for over 20,000 children. Their professional services coupled with loving staff and a Christian environment make Tennessee Children's Home one of the finest programs in the state.

The Tennessee Children's Home Campus in Knoxville initially got its start as the East Tennessee Christian Services in 1979. The desire of several individuals saw a need to provide services for children in the eastern part of the state. In 1987, the construction of a home began on property that was acquired from Hillbrook Christian Association. In 1988, the home opened its doors; it could accommodate up to 8 youth and was named Cherrybrook. The land obtained from Hillbrook Christian Association was originally owned by Harold and Della Duncan. The Duncan's donated 54 acres with the intent the property would be used for various religious activities such as worship, edification,

evangelism, support of orphans, education, and benevolence. In January 2001, East Tennessee Christian Services merged with Tennessee Children's Home and 17 acres of the land was transferred to the Tennessee Children's Home.

In August of 2015, the East campus expanded by adding two more group homes and a multipurpose building that would serve as a school and administrative offices. The expansion allowed the campus to increase the number of residents it could serve from 8 to 16 and added an onsite school named Duncan Academy. The East campus serves at-risk males age 13 to 18 in a residential setting where they receive behavioral modification treatment using the Equip Program model. The Equip program is designed to teach youth to think and act responsibly through a peer help approach. The campus also provides Alcohol and Drug Education. Duncan Academy is a fully certified State School. Since 2016 we have had 12 students obtain their high school diploma and graduate from our school.

The East campus began a renovation of the Cherrybrook Home in August of 2020. The project will convert the home to have 8 bedrooms and 9 bathrooms. This will provide extra safety and security for the youth in their care. It will also provide more continuity between all houses on the campus.

TCH East is situated on 17 acres. There are four (4) buildings on campus. There are three (3) residential housing units. Each house provides living space for eight (8) residents and two (2) house parents. At any time only two (2) housing units are open housing 16 residents. House parents work two weeks on and then have a week off. Residents are moved to another housing unit when the house parents are off for a week. During the on-site audit one house was being renovated. During sleeping hours from 9:00 p.m. to 6:00 a.m. the residents are supervised by an awake night staff located in each housing unit. The night staff conduct rounds that are recorded on a log. The housing units and main building use video monitoring as part of supervision. TCH East relies on staff coverage for supervising residents. The facility has a school, gymnasium, and administrative offices.

## **Services Available**

### **Residential**

As the flagship program at Tennessee Children's Home, the residential care encompasses almost all of the services TCH provides. They provide for physical, social, emotional, spiritual, and educational needs of the children and youth in a safe and secure environment. Children may be placed in their care through the state or through personal placements. The children live in on-site homes in family situations with other children, and with house parents/residential counselors. These residential counselors are the primary care givers and are assisted by the case workers and other staff. The residential program at Tennessee Children's Home is highly structured to help the children be successful, and includes:

- Daily chores
- On-site school (including Bible classes)
- Tutoring services
- Church attendance
- Counseling services (for both children and families)
- Substance abuse counseling

On weekends, the parents may visit their children or children may go home; recreational activities are provided for those remaining on campus. In its entirety, the residential care program helps the children entrusted to us develop life skills, self-discipline and a greater understanding of their worth as children of God.

### **Education**

Tennessee Children's Home offers on-site instruction by certified teachers for residential placements through the Cornerstone School (SH), Duncan Academy (ET), and New Heights Schools (WT). Experience has shown that teachers dedicated and focused on ensuring the children's academic success are crucial in developing healthy self-esteem. Because of this, educational services have become foundational in programming.

TCH schools offer special education, as well as tutoring, and mitigate any truancy issues by being located on campus. They are committed to maintaining a student-teacher ratio of one teacher to every eight students. This specialized attention, coupled with on-site tutoring and accountability, has allowed children that are two and three years behind in school to regularly return to grade level work within just six months.

### **Substance Abuse Education**

Tennessee Children's Home is a level II facility that provides care for teenage boys with moderate clinical needs who are unable to live at home or in a foster home, and who require temporary care in a group or residential setting. The treatment consists of residential behavioral intervention using the EQIUP model to provide a highly structured home and school environment. Individual and Family counseling, family involvement and residential counseling helps to support both our youth and their families struggling with behavioral issues and substance abuse.

The program has weekly substance abuse group education that follows the nationally recognized curriculum: Hazelton Living in Balance program. This curriculum covers the following: assessment of mental and physical needs, treatment planning, individual assignments, education about substance use disorders, life skills training, maintaining sobriety, relapse prevention training, individual and family therapy and finally advocating of continued support from a twelve-step group or support from their family and friends.

TCH offers aftercare services that help our youth to transition back into their home and community and ensure a successful reunification.

### **Counseling**

The Therapist's at the Tennessee Children's home offer family, individual and group counseling to all the residents and their families. The services offer a safe space for families and adolescents to work on communication and relationship building.

The therapists employ many modalities when it comes to working with clients in therapy including: CBT, experiential, solution focused and EMDR. TCH believe it is never too late to build a stronger family. They love to walk alongside clients as they gain the insight to make small and large life adjustments. These insights lead to reduced stress and a better overall well-being.

### **Spiritual Guidance**

The caring staff encourage children's spiritual growth and awareness through personal examples, daily devotions, prayers at meals and encouragement of regular church attendance.

The Facility Director confirmed TCH is obligated by DCS to maintain ratios of staff-to-youth ratios of 1:5 during the day and 1:8 at night. He ensures the facility maintains appropriate staffing.

The PREA Coordinator confirmed being consulted regarding any assessments of, or adjustments to, the staffing plan. She confirmed the assessment occurs annually and is documented through the Staffing Plan Assessment. The auditor reviewed the 2020 Staffing Plan Assessment for verification.

PAQ: The facility requires that intermediate-level or higher-level staff conduct unannounced rounds to identify and deter staff sexual abuse and sexual harassment. The facility documents unannounced rounds. The unannounced rounds cover all shifts. The facility prohibits staff from alerting other staff of the conduct of such rounds.

Policy states each secure agency develops written local search procedures of intermediate-level or higher-level supervisors to conduct and document unannounced search rounds to identify and deter

staff sexual abuse and sexual harassment. Written local search procedures are implemented for both day and night shifts.

The Facility Director confirmed the PAQ responses. He stated the unannounced rounds are documented in logbooks. He prevents staff from alerting other staff that he is conducting the unannounced rounds by not announcing the purpose of the rounds.

PREA Site Review: During the onsite tour of the facility the auditor observed the classrooms and homes were compliant with the staffing ratios. Staff were actively supervising and engaging with the residents.

### **Corrective Action**

Based upon review and analysis of the available evidence, the auditor has determined the agency and facility is fully compliant with this standard regarding supervision and monitoring. No corrective action is required.

Resident interviews confirmed female staff announce their presence before entering residents' rooms and residents are never naked in full view of female staff. Each resident has his own bathroom with a shower.

Staff interviews confirmed female staff announce their presence before entering residents' rooms. Staff confirmed residents are able to dress, shower, and use the toilet without being viewed by staff of the opposite gender.

PREA Site Review: Staff conducting the tour described the shower process. Each resident has his own bathroom with a shower.

PAQ: The facility has a policy prohibiting staff from searching or physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status. Zero (0) such searches occurred in the past 12 months.

Policy states transgender or intersex youth will not be searched or physically examined for the sole purpose of determining genital status. Staff interviewed confirmed they are aware policy prohibits them from searching or physically examining a transgender or intersex resident for the purpose of determining the resident's genital status.

TCH ensures residents with disabilities have an equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. However, the facility does not accept juveniles with an IQ lower than 70.

Policy states appropriate provisions are made as necessary for children/youth who are limited English proficient, have disabilities (including those who are deaf or hard of hearing, those who are blind or have low vision), and those with low intellectual, psychiatric, or speech disabilities.



The President confirmed the agency has established procedures to provide disabled residents equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. There were no residents (with disabilities or who are limited English proficient) who were identified during the onsite audit.

The TCH Human Resources Director confirmed the facility performs criminal record background checks and considers pertinent civil or administrative adjudications for all newly hired employees who may have contact with residents and all employees, who may have contact with residents, who are being considered for promotions. The facility also consults the Tennessee Department of Children’s Services Database.

The auditor reviewed Employee Background Checks and Tennessee Department of Children's Services Database Search Results for verification.

The project will convert the home to have 8 single bedrooms and 9 bathrooms. The renovations will provide extra safety and security for the residents.

The President and Facility Director both confirmed the facility considers the ability to protect residents from sexual abuse when designing or acquiring any new facility and in planning any substantial



expansion or modification of existing facilities. Also, the agency would consider the effect of the design, acquisition, expansion, or modification upon the agency's ability to protect residents from sexual abuse.

**PREA Site Review:**

The auditor observed the last of three homes was being modified to single rooms with individual bathrooms.

During the intake process, residents receive information explaining, in an age appropriate fashion, the TCH zero-tolerance policy regarding sexual abuse, sexual assault, sexual misconduct, and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Resident education is accomplished through reviewing the PREA Comprehensive Education Curriculum, PREA brochures and resident handbooks.

The Case Manager confirmed residents are educated on the facility's zero-tolerance policy on sexual abuse and sexual harassment and how to report during intake. Written and verbal information on PREA is provided and explained to all residents within forty-eight (48) hours of intake. Residents interviewed confirmed they were informed of their right not to be sexually abused and sexually harassed, how to report, and their right not to be punished for reporting, during the intake process. They confirmed they received information about the facility's rules against sexual abuse and harassment through pamphlets and resident handbooks.

The auditor reviewed intake records of residents entering the facility in the past 12 months and residents interviewed for verification. This information is documented with the Youth Acknowledgement of PREA. The auditor also reviewed relevant education materials including resident handbooks, pamphlets, and the PREA educational video.

The Case Manager confirmed TCH ensures that residents are educated regarding their rights to be free from sexual abuse and sexual harassment, and to be free from retaliation for reporting such incidents, and regarding agency policies and procedures for responding to such incidents by providing the information in various educational formats and requiring the residents to sign an acknowledgment form stating they understand the information. He confirmed residents are made aware of these rights within forty-eight (48) hours after intake. Residents interviewed confirmed they were informed of their right not

to be sexually abused and sexually harassed, how to report, and their right not to be punished for reporting, during the intake process. Residents stated they received the information on their first or second day at the facility. They also confirmed they received information about the facility's rules against sexual abuse and harassment.

The auditor reviewed intake records of residents entering the facility in the past 12 months and residents interviewed for verification. This information is documented with the Youth Acknowledgement of PREA. The auditor also reviewed relevant education materials including resident handbooks, pamphlets, and the PREA educational video.

Specialized training for mental health care staff was completed 12/23/20. Training confirmation was received for verification.

**Findings (By Provision):**

**115.341 (a)**

PAQ: The agency has a policy that requires screening (upon admission to a facility or transfer to another facility) for risk of sexual abuse victimization or sexual abusiveness toward other residents. The policy requires that residents be screened for risk of sexual victimization or risk of sexually abusing other residents within 72 hours of their intake.

The policy requires that a resident's risk level be reassessed periodically throughout their confinement.

Policy states during the intake process, DCS form CS-0946 Assessment, Checklist and Protocol for Behavior and Risk for Victimization is administered to all children/youth within seventy-two (72) hours of admission to TCH. Residents are reassessed for risk of sexual victimization or risk of sexually abusing other residents every 90 days.

The auditor reviewed completed DCS form CS-0946 Assessment, Checklist, and Protocol for Behavior and Risk for Victimization examples for verification.

The Case Manager confirmed he screens residents upon admission to the facility or transfer from another facility for risk of sexual abuse victimization or sexual abusiveness toward other residents. He stated she screens residents for risk of sexual victimization or risk of sexually abusing other residents within 72 hours of their intake. The information is ascertained through conversations with residents during intake, medical and mental health screenings, and reviewing any relevant court records. Resident's risk levels are reassessed every ninety (90) days.

Residents interviewed confirmed when they first came to the facility, they were asked questions like whether they have ever been sexually abused, whether they identify with being gay, bisexual or

transgender, whether they have any disabilities, and whether they think they might be in danger of sexual abuse at the facility. They stated they were asked these questions the first or second day at the facility.

**115.341 (b)**

PAQ: Risk assessment is conducted using an objective screening instrument. DCS form CS-0946 Assessment, Checklist and Protocol for Behavior and Risk for Victimization objective screening instrument.

Based upon review and analysis of the available evidence, the auditor has determined the agency and facility is fully not compliant with this standard regarding obtaining information from residents. Corrective action has been completed.

**Findings (By Provision):**

**115.342 (a)**

PAQ: The agency/facility uses information from the risk screening required by §115.341 to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse.

The “At-Risk Protocol” section of form CS-0946 Assessment, Checklist, and Protocol for Behavior and Risk for Victimization is initiated and completed on all residents who are identified as vulnerable for being at-risk of sexual victimization or identified as having the potential to victimize or perpetrate, especially in regards to sexually aggressive behavior.

The auditor reviewed the risk assessments for verification the facility uses information from the screening information to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse. The PREA Compliance Manager confirmed the facility uses information from the risk screening during intake to keep residents safe and free from sexual abuse and sexual harassment by determining housing and room assignments. The Case Manager further identified that rooms assignments closer to the staff office are where victims or vulnerable youth are placed.

**115.342 (b)**

PAQ: The facility has a policy that residents at risk of sexual victimization may only be placed in isolation as a last resort if less restrictive measures are inadequate to keep them and other residents safe, and only until an alternative means of keeping all residents safe can be arranged. The facility policy requires that residents at risk of sexual victimization who are placed in isolation have access to legally required educational programming, special education services, and daily large-muscle exercise. In the past 12 months:

The PREA Compliance Manager and Case Manager confirmed placement and programming assignments are reassessed at least twice each year to review any threats to safety experienced by the resident.

#### Findings (By Provision):

##### 115.351 (a)

PAQ: The agency has established procedures allowing for multiple internal ways for residents to report privately to agency officials about: Sexual abuse or sexual harassment; Retaliation by other residents or staff for reporting sexual abuse and sexual harassment; AND Staff neglect or violation of responsibilities that may have contributed to such incidents.

The facility provides internal ways for residents to privately report sexual abuse and sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. These internal ways of reporting include telling any staff member or filing a grievance. Grievance forms and boxes are available for the residents. Residents can keep a pencil for writing grievances and the grievance boxes are checked daily.

Staff interviews confirmed residents can privately report sexual abuse or sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, or staff neglect or violation of responsibilities that may have contributed to an incident of sexual abuse or sexual harassment by calling the DCS hotline number. Residents stated they would report sexual abuse or sexual harassment that happened to them or someone else by telling staff, calling the hotline, or writing a grievance.

**115.351 (b)**

PAQ: The agency provides at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency. The agency has a policy requiring residents detained solely for civil immigration purposes be provided information on how to contact relevant consular officials and relevant officials of the Department of Homeland Security.

Residents may also report externally to a public or private entity or office that is not part of the agency. This includes but is not limited to: (1) DCS Child Abuse Hotline at 1-877-237-0004 and (2) John L. Attorney or Guardian ad Litem. Residents may remain anonymous upon request.

Residents detained solely for civil immigration purposes are provided information with their resident handbook on how to contact relevant consular officials and relevant officials at the Department of Homeland Security. The facility has not had any residents detained solely for civil immigration purposes.

The PREA Compliance Manager identified the DCS hotline as one way residents can report sexual abuse or sexual harassment to a public or private entity that is not part of the agency. Calling the DCS hotline enables receipt and immediate transmission of resident reports of sexual abuse or sexual harassment to agency officials and allows the resident to remain anonymous upon request. Residents stated they would report sexual abuse or sexual harassment that happened to them or someone else by telling staff, calling the hotline, or writing a grievance. They also could identify someone that does not work at the facility they could report to.

The auditor observed posters with information for reporting sexual abuse or sexual harassment.

Pursuant to Tennessee Code Annotated 37-1-403, any person who has knowledge of or is called upon to render aid to any child/youth who is being sexually abused, sexually assaulted, or sexually harassed has the duty to report such abuse. In terms of PREA standards, this duty to report includes but is not limited to any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is part of the agency. All reports made verbally, in writing, anonymously, by third parties or by any other means must be reported.

Interviews with staff confirmed when a resident alleges sexual abuse or sexual harassment, he can do so verbally, in writing, anonymously and through third parties. Staff stated they document verbal reports. Most said immediately, but all stated they would document as soon as possible. Residents confirmed they can make reports of sexual abuse or sexual harassment either in person or in writing and someone else could make the report for them, so they do not have to give their name.

Information includes local, state, and national victim advocacy and rape crisis organizations. TCH East is in the process of obtaining a MOU for victim advocates with The Sexual Assault Center of East Tennessee.

PAQ: The agency requires all staff to comply with any applicable mandatory child abuse reporting laws.

Duty to Report - As per Tennessee Code Annotated 37-1-403 and 37-1-605 Pursuant to TCA 37-1-403 and 37-1-605, any person who has knowledge of or is called upon to render aid to any child/youth who is being sexually abused, sexually assaulted or sexually harassed has the duty to report such abuse.

Staff confirmed PREA training includes how to comply with relevant laws related to mandatory reporting of sexual abuse.

Staff confirmed the agency requires all staff to report any knowledge, suspicion, or information regarding an incident of sexual abuse or sexual harassment that occurred in a facility; retaliation against residents or staff who reported such an incident; and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation. They stated they would report to their supervisor and DCS.

An interviews with the Treatment Director confirmed he discloses the limitations of confidentiality and his duty to report at the initiation of services to a resident. He confirmed he is required by law to report any knowledge, suspicion, or information regarding an incident of sexual abuse or sexual harassment upon learning of it. He reported he has become aware of such incidents over two years ago and reported them.

Upon receiving any allegation of sexual abuse, the Facility Director or his designee shall promptly report the allegation to the alleged victim's parents or legal guardians, unless TCH has official documentation showing the parents or legal guardians should not be notified. The Facility Director/PREA Compliance Manager confirmed when the facility receives an allegation of sexual abuse the allegation is reported to the DCS Child Abuse Hotline and the victim's legal guardians as appropriate. This notification would usually occur within a few hours in which the allegation was received. If a juvenile court retains jurisdiction over the alleged victim, he will report the allegation to the juvenile's attorney. All allegations of sexual abuse and sexual harassment are reported to the DCS Special Investigations Unit. TCH does not conduct administrative or criminal investigations.

**115.361 (f)**

TCH policy requires all allegations of sexual abuse must be reported to the DCS Child Abuse Hotline at 1-877-237-0004. DCS ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse/assault/misconduct/harassment.

The Facility Director confirmed all allegations of sexual abuse and sexual harassment (including those from third-party and anonymous sources) are reported directly to designated facility investigators.

All staff members are required to report immediately and according to TCH policy retaliation against residents who reported sexual abuse or sexual harassment. Staff members have a duty to report staff neglect or violations of responsibilities that may have contributed to an incident or retaliation.

The length of time that the agency and/or facility monitors the conduct or treatment: 90 days

The agency/facility acts promptly to remedy any such retaliation.

The agency/facility continues such monitoring beyond 90 days if the initial monitoring indicates a continuing need.

The number of times an incident of retaliation occurred in the past 12 months: Zero (0)

For a period of ninety (90) days following a report, TCH monitors the treatment of residents or staff that made a report and the residents who were reported to be abused to identify attempts at retaliation or negative consequences and will act immediately to remedy any such actions. Monitoring should include, but not limited to: (1) Resident disciplinary reports, housing, or program changes; (2) Negative performance reviews or staff reassignments; and (3) Periodic status checks of residents. The agency continues monitoring beyond ninety (90) days if evidence indicates a continued need.

The Facility Director stated measures he would take when he suspects retaliation is removal of alleged resident or staff abusers. He stated things he looks for to detect possible retaliation include changes in behavior. He monitors resident disciplinary reports. He stated he would monitor the conduct and treatment of residents and staff who report the sexual abuse of a resident or were reported to have suffered sexual abuse for 90 days. If there is concern that potential retaliation might occur, the maximum length of time that the facility would monitor conduct and treatment would be until a youth is released from the facility.

Policy states monitoring will include periodic status checks of residents. The Facility Director stated things he looks for to detect possible retaliation include changes in behavior.

The Facility Director stated the different measures he would take to protect residents and staff from retaliation is removal of alleged resident or staff abusers.

The facility policy requires that residents who are placed in isolation because they allege to have suffered sexual abuse have access to legally required educational programming, special education services, and daily large-muscle exercise.

If a resident who alleges to have suffered sexual abuse is held in isolation, the facility affords each such resident a review every 30 days to determine whether there is a continuing need for separation from the general population.

The Facility Director confirmed TCH does not use isolation.

##### 115.371 (a)

DCS is responsible for allegations of sexual abuse or sexual harassment. The DCS investigator stated once a case is received, it takes less than 24 hours to initiate an investigation following an allegation of sexual abuse or sexual harassment. The investigator confirmed she handles anonymous or third-party reports of sexual abuse and sexual harassment in the same manner as all investigations. She begins by interviewing the individual who reported the allegation.

**115.371 (b)**

DCS investigators receive specialized training in sexual abuse investigations involving juveniles. The DCS investigator confirmed she received training specific to conducting sexual abuse and sexual harassment investigations in confinement settings through classroom and computer-based training. She confirmed she received the required training,

The DCS Investigator gathers all evidence, reviews video surveillance footage if available, and interviews alleged victims, suspected perpetrators, and witnesses. The investigation will include reviewing any prior complaints and reports of sexual abuse involving the suspected perpetrator. The investigator will not terminate the investigation solely because the victim recants the allegation.

The DCS investigator confirmed the first steps in initiating an investigation is contacting the facility where an allegation of sexual abuse or sexual harassment has been made and requesting all available information. This occurs within 24 hours. She then travels to the facility to review any video footage that may be available, and conducts interviews with the alleged victim, alleged perpetrator, and all witnesses. Direct and circumstantial evidence she would be responsible for gathering in an investigation of an incident of sexual abuse would include video footage, interviews, statements, third-party information, etc.

The DCS investigator confirmed an investigation does not terminate if the source of the allegation recants the allegation.
