FROM THE PRESIDENT

I can't believe a year has gone by since the last *Pathways* was sent out! Thank you for all your prayers and support throughout the year for the programs and the mission Tennessee Children's Home provides for children and families in the state of Tennessee.

We have stayed busy on all the campuses. Our programs are producing great outcomes. Many youth are being reunited with their families and most stay out of state custody if they complete our program successfully. I believe we have the best staff of any home in Tennessee. They are true servants and have hearts to help struggling youth. Please keep our families, youth and staff in your prayers.

In 2018, sixteen young people obeyed the Gospel. This year there have already been 14 that have committed their lives to Christ by obeying the Gospel. This represents the number of forgiven souls. Thank you for your support so these young people in our residential programs can hear the good news. Seeds are being sown for God to give the increase.

Lord willing, some monumental things are about to occur. The campus in Spring Hill is under contract and once the city approves we will be able to close on the deal. If all works out, we should be able to start building our new campus on Beechcroft and Dr. Robertson roads by the first of next year. The other contracts we have had never made it this far and we are very pleased.

Our land and campus at the North Central campus are also under contract. The land around the campus is set to close by the end of October 2019. The same buyer wants to purchase the campus by the end of October 2020. Once the campus is purchased we will move our programs and services to an apartment building we are currently leasing in Clarksville, Tennessee. Our new Independent Living Program for young women, ages 18-24, which was developed last fall is also located there. It provides assistance to those who have aged out of state custody.

The East campus had its' best year since the merger in 2000. They have served more youth this past year and have maintained full staff even through changes. We have a need for Residential Counselors and a teacher as soon as possible. If you know of anyone qualified, please give us a call. Rich Johnston and his staff are doing a great job.

Our West TN campus has changed the most. Dr. Larry Ivery is now the Treatment Director and Jeremy Northrop is Executive Director. The past few years have been difficult on this campus. We have only been able to serve about half the youth we are licensed to serve due to lack of staff. In spite of this the staff are dedicated to providing quality care to the youth we serve. Residential Counselors are also needed at this campus.

Thank you again for your continued support. We can't do this without you. We need your financial support, but we also need YOU to commit to working with our youth so we can have more of an impact in the future. •

OUR MISSION

Tennessee Children's Home is committed to improving the lives of those we influence through quality services in a Christian atmosphere.

OUR VISION

Those served by Tennessee Children's Home will learn to live healthy physical, mental, social, and Christian lives.

WHAT WE DO

Tennessee Children's Home provides group home residential treatment, child and family counseling, and independent living programs. The purpose of TCH is to support, educate and provide Christian out-of-home care for children who are victims of abuse, dependent neglected, orphaned, and/or exploited, making all reasonable and practical efforts to provide services to meet their intellectual, emotional, physical and spiritual needs. A further purpose is to provide family intervention that is intended to prevent or reverse family disintegration through a series of community based and family based intervention strategies.

With four campuses located across the state, Tennessee Children's Home is able to offer a variety of services to children and their families. These include residential care for children placed by the Department of Children's Services and/or Juvenile Justice and classified as needing Level II services. TCH also offers A&D programs. The group home residences are family oriented-serving no more than 8 children per house under the guidance of Christian house parents. Each campus offers supervised recreational facilities such as gymnasiums, lakes for fishing and boating, swimming pools, low and high ropes course, nature trails, softball fields, volleyball, exercise and weight-lifting equipment, games rooms, and other activities.

All the children in our care, regardless of the program, receive professional counseling. For some privately placed children, those classified as Level II, TCH offers on-campus and highly structured, therapeutic educational facilities. TCH also provides a minimum 3-month monitoring program to assist children and their families in the transition back into home, school, and work environments.

OUR PROGRAM

The Level II residential care program is designed for children who may be abused or neglected and who may exhibit runaway or delinquent behavior. They may have problems with their families, local law enforcement, school environments, or with their own personal behavior. The children served are between 13 and 18 years old. The children receive individual and group counseling, assistance with individual problems, and behavior modification instruction designed to help them become responsible adults. They live in group homes designed to be as family integrated as possible.

The Cornerstone School in Spring Hill, Duncan Academy in Knoxville, and New Heights in Pinson are the on-campus schools that provide for the educational needs of children in Level II programs and private placements. Most of these children are academically behind and/or have special learning needs. The school offers a structured and treatment-oriented environment, a 6:1 student-teacher ratio, tutoring, and special education classes. Students take courses in Math, Science, English, Reading, Life Skills, Physical Education, and Bible.

As Tennessee Children's Home works with abused, neglected, wayward, and orphaned children and youth, all reasonable and practical efforts are made to provide services to meet their intellectual, emotional, physical, and spiritual needs. This program has already proven successful as we observe the changes in student's behavior. The children become more self-confident, have less personal behavioral problems and are more productive as members of their community. We are providing the highest quality program promising the overall growth and success of each child in our care. •

Become a Residential Counselor

What comes to your mind when you hear the word Children's Home? Does it make you think of an orphanage? Does it make you think of a place where kids go because their living arrangement is not sufficient? It's possible that you think of a place where troubled youth are sent in order to straighten out their behavior. All of these would be correct. The term orphan in simple terms means one who is separated from their primary relationship. All of these situations depict orphans or those who have been separated from their primary caregiver. Another common term applied to this situation today is "at-risk youth".

There is a huge need for Christians who are willing to provide care for these children. It is my belief that there are plenty of people that are qualified to do this work but sometimes the information may not reach the correct people. While there are people from all walks of life that can succeed at this job, I am going to list at least 3 types of people that would do well serving at-risk youth.

1. The Preaching School Graduate looking for a job.

Graduating from preaching school can be overwhelming. It becomes time to decide where you and your family will be located in the ministry. Maybe you're not sure where that best place is. It may even be that there's not a job opening at the time needed. Men with a background in preaching often do well in this work. If their mindset is to serve in whatever way possible, becoming a Residential Counselor at Tennessee Children's Home allows for part-time preaching. We currently have many employees who preach most weekends. This would allow for the recent graduate to gain some pulpit time while figuring out his next best place to serve.

2. The Empty-Nester Couple looking for opportunities to serve.

The empty nester couple is perfect for this type of position. It allows you to keep the heart of the Gospel, which is others first, while at the same time allowing time for your own children. The schedule also works someone who wants to travel to see kids at school and in their new endeavors. This is a great opportunity to grow closer to the Lord and your spouse through ministry.

3. Anyone who understands what the Bible says about taking care of those in need.

We should all have that mentality and make that a part of our lives. In this case, if someone wants to make it a full-time priority, look no further. Housing is provided. Utilities: paid for. Plus, you will be compensated for your time with a pay and benefits.

Consider being a Residential Counselor at Tennessee Children's Home. There is no better time to impact the life of an at-risk youth than right now! •

Special Education Teacher: *TCH-East (Knoxville)* is seeking a full-time Special Education Teacher for their on-site school. Will work closely with all TCH staff in keeping with a team approach to meet the needs of students. Will plan, organize and implement an appropriate instructional program in a learning environment that guides and encourages students to develop and fulfill their academic potential. Must hold a Bachelors' degree or higher from an accredited institution and have a state certification in special education.

Teachers: *TCH-Middle (Spring Hill)* is seeking two full-time teachers for their on-site school. Will work closely with all TCH staff in keeping with a team approach to meet the needs of students. Will plan, organize and implement an appropriate instructional program in a learning environment that guides and encourages students to develop and fulfill their academic potential. Must hold a Bachelors' degree or higher from an accredited institution. Meet professional teacher education requirements of school, district, and state and be state certified.

Night Staff: *TCH-Middle, TCH-East (Spring Hill & Knoxville)* is seeking at least one full-time and one part-time night staff to supervise youth during sleep hours of 10:00 PM-6:00 AM. High School diploma or GED equivalent required, at least 21 years of age, prefer someone with experience working with youth.

Residential Counselors: *TCH-West (Pinson)* is seeking full-time Residential Counselor Couples (formerly houseparents) to be responsible for the day-to-day care, guidance, and training of the youth assigned to residence, all in keeping with the program policies and procedures. Must have a minimum of a high school diploma or GED, advanced education preferred and one-year experience working with children and youth.

Residential Counselors: *TCH-East (Knoxville)* is seeking full-time Residential Counselor Couples (formerly houseparents) to be responsible for the day-to-day care, guidance, and training of the youth assigned to residence, all in keeping with the program policies and procedures.

Jesus said, "Those who are well have no need of a physician, but those who are sick. I came not to call the righteous, but sinners" (Mark 2:17).

Young people that are aggressive and violent, maybe on alcohol and drugs, could be in a gang. Teenagers that have promiscuous sex, maybe they self-injure, some steal, lie, and could be suicidal.

Does this list terrify you?

It's hard to imagine ministering and sharing God's word with these types of children and youth. It's scary and challenging. If one of our teenagers attended my congregation, would I walk past them without a word? Would I avoid eye connect? Would I sit far away from them?

Who has the patience and time to spend with troubled youth? Who can love them enough to share the hope of salvation? Tennessee Children's Home (TCH) does this every day.




Rumor: TCH takes in children in the custody of the State of Tennessee and they get funding for each child. So, if TCH takes State of Tennessee funds they cannot share the Word of God.

Truth: TCH does help children in State's custody. But, the State does not regulate against religious beliefs. State funding does not come close to providing everything a child needs, thus TCH continues to rely on church and individual donations.

TCH has individual and group Bible studies, chapel on Monday morning, devotionals, church services, and Bible study classes. We thank every congregation that our young people attend for your encouragement. Giving just one teenager a hand shake or kind word means so much. You are the hands and feet of Christ and it shows.

In 2018, TCH had a total of 16 baptisms across the state. •





Upon graduating from Lipscomb University in 2017 my wife, Jentry, and I both had our degrees and were waiting for what was to come when we found Tennessee Children's Home. We decided that instead of pursuing careers with our degrees, God was calling us to serve here in Knoxville with at-risk youth. Over the past two years I have had the opportunity to serve both as a Residential Counselor and as a Teacher.

I have always known that God gave me the skills to become a teacher, but it wasn't until my time with Tennessee Children's Home that I discovered my calling to serve this population.

Tennessee Children's Home has helped me grow more spiritually than I could have ever imagined. I have been able to see boys from all walks of life turn towards God and follow Him. In the fall of 2018, Tennessee Children's Home began an Independent Living program for young adult ladies (18-21) in Clarksville, Tennessee. This program has the potential to give young women, who have been released from state custody at or after age 18, the opportunity of a lifetime. To be eligible they need to be enrolled in a post-secondary or vocational education institution and work at least part-time. Doris McCugh is the on-site supervisor at an apartment building where three (3) three-bedroom townhomes are available for the young women. Doris provides counseling and help in dealing with daily issues. She conducts weekly training sessions to teach some basic independent living skills: cleaning, laundry, budgeting, grocery shopping, cooking, riding Clarksville transit and filling out job applications to name a few. A total of five young women have been able to take advantage of this program and two still remain with us.

Tennessee Children's Home has been given the capability to help these young ladies achieve their educational and life goals. They have to want this opportunity. In the end, the most important possibility Tennessee Children's Home has with these young ladies is to teach them about the love of Jesus Christ and what a difference he can make in their lives. •

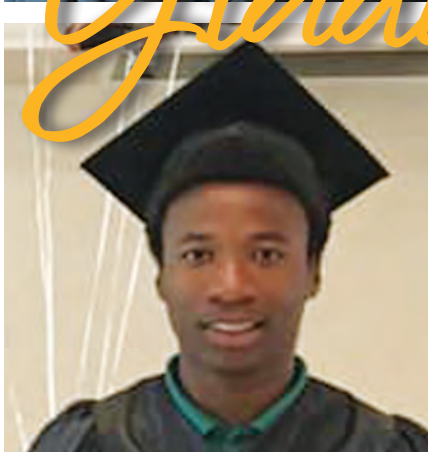
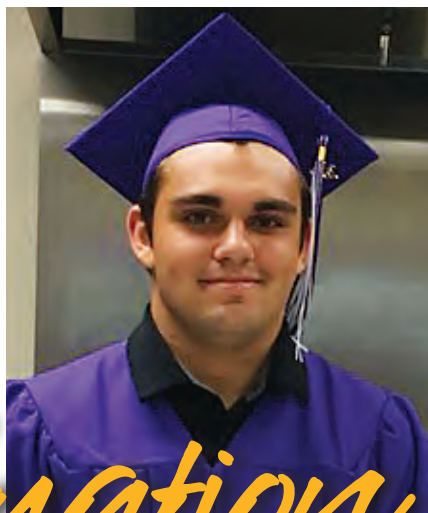
