What a difference a year can make! Thankfully, we are all slowly getting back to our normal state.

Our new campus is about 70% complete and we are expected to be handed the keys in October 2021! DeAngelis Diamond has done an exceptional job helping us keep ahead of schedule and below budget. We are excited about our relocation and giving us the ability to better serve at-risk youth and their families.

An Open House is tentatively scheduled for October or November. We have raised about \$2,400,000 of the \$4,000,000 needed to finish the buildings. You can read more about our campaign in the Development Report from Chris Doughtie. Thank you to those who have helped with special contributions.

On the day of Pentecost 3,000 people responded to the Gospel message. Today, will you be one of 3,000 who guarantee Christian love, education, and spiritual hope for at-risk youth in Tennessee? We need only \$1,600,000 to complete this project. Will you be one of 1,000 people who give \$1,000 or one of 2,000 people who give \$500? Your donation can be given over a year or given all at once. Other news across the state:

North Central campus moved from Ashland City to Clarksville, Tennessee. We now own two apartment units to house our Independent Living Program for young adults and the Displaced Families Program. These are much-needed services and RozeEllen Beamer has done a great job with this transition.

East Tennessee campus completed some renovation on the CherryBrook house, making each bedroom have its own bathroom. Now all residents have their own bedroom and bathroom in each of the houses. Thanks to Rich Johnston, Troy McCord, and Joel Halsey for the work they did to complete this project.

West Tennessee campus will be starting back with their renovations after a brief pause due to the pandemic. Jeremy Northrop, the Executive Director of West will be leaving us to teach at Freed-Hardeman University in July. He has been with the children's home for over seven years, and he will be missed. I will be interviewing qualified candidates in July 2021.

By the end of 2022, our 112-year-old organization will have all our facilities either updated and renovated or in new buildings. We are thankful that God has been with us and will continue to guide us in our decisions.

OUR MISSION

Tennessee Children's Home is committed to improving the lives of those we influence through quality services in a Christian atmosphere.

OUR VISION

Those served by Tennessee Children's Home will learn to live healthy physical, mental, social, and Christian lives.

WHAT WE DO

Tennessee Children's Home provides group home residential treatment, child and family counseling, and independent living programs. The purpose of TCH is to support, educate and provide Christian out-of-home care for children who are victims of abuse, dependent neglected, orphaned, and/or exploited, making all reasonable and practical efforts to provide services to meet their intellectual, emotional, physical and spiritual needs. A further purpose is to provide family intervention that is intended to prevent or reverse family disintegration through a series of community based and family based intervention strategies.

With four campuses located across the state, Tennessee Children's Home is able to offer a variety of services to children and their families. These include residential care for children placed by the Department of Children's Services and classified as needing Level II services. TCH also offers Alcohol and Drug programs. The group home residences are family oriented-serving no more than 8 children per house under the guidance of Christian house parents. Each campus offers supervised recreational facilities such as gymnasiums, softball fields, volleyball, exercise and weight-lifting equipment, games rooms, and other activities.

All the children in our care, regardless of the program, receive professional counseling. For some privately placed children, those classified as Level II, TCH offers on-campus and highly structured, therapeutic educational facilities. TCH also provides a minimum 3-month monitoring program to assist children and their families in the transition back into home, school, and work environments.

OUR PROGRAM

The Level II residential care program is designed for children who may be abused or neglected and who may exhibit runaway or delinquent behavior. They may have problems with their families, local law enforcement, school environments, or with their own personal behavior. The children served are between 13 and 18 years old. The children receive individual and group counseling, assistance with individual problems, and behavior modification instruction designed to help them become responsible adults. They live in group homes designed to be as family integrated as possible.

The Cornerstone School in Spring Hill, Duncan Academy in Knoxville, and New Heights in Pinson are the on-campus schools that provide for the educational needs of children in Level II programs and private placements. Most of these children are academically behind and/or have special learning needs. The school offers a structured and treatment-oriented environment, a 6:1 student-teacher ratio, tutoring, and special education classes. Students take courses in Math, Science, English, Reading, Life Skills, Physical Education, and Bible.

As Tennessee Children's Home works with abused, neglected, wayward, and orphaned children and youth, all reasonable and practical efforts are made to provide services to meet their intellectual, emotional, physical, and spiritual needs. This program has already proven successful as we observe the changes in student's behavior. The children become more self-confident, have less personal behavioral problems and are more productive as members of their community. We are providing the highest quality program promising the overall growth and success of each child in our care. •

HOPE

In 2019, the West campus of the Tennessee Children's Home began an extensive remodel project. Much of the work conducted was ordinary maintenance which could not wait any longer. Several roofs had shingles replaced, some duct work was added, and some much-needed flooring was installed. A big part of the remodel work was converting some bathrooms. At one house, four shared bathrooms were converted into eight individual bathrooms allowing each room in the house to have its own bathroom. Through the process which continued over about 18 months, it was discovered more work needed to be done. In fact, some unexpected expenses came up which had to be addressed immediately. Other facets of the project now must be completed.

Of course, COVID-19 happened with the safe-at-home directive and other edicts were put in place to maintain public health. Tennessee Children's Home worked hard to comply with the local and federal ordinances surrounding the coronavirus. As most know, many of the mandates have been lifted and culture seems to be returning to normal (whatever that means). In compliance with the ordinances, Tennessee Children's Home – West limited visitors to campus as well as off-campus outings. Thus, it was decided to put the remodel project on hold until a safer time. While no one knows the future, it seems the time is nearing in which the remodel work will be resumed.

As all are aware, remodel work is not free! While we are working hard to practice good stewardship, the unexpected expenses as well as some other costs which have turned out to be more costly than envisioned, necessitate the need for additional funding. We still have one house which needs new flooring as well as two shared bathrooms which need to be converted to four individual bathrooms. There are some maintenance remodel plans for the administration building also.

Will you kindly consider helping us? In the recent weeks, we have launched a campaign entitled "Maintaining Hope" and we are seeking to raise \$200,000. The initiatives funded by this campaign will enable us to better serve the at-risk adolescents of Tennessee. •

REMODELING *Cherrybrook*

Way back in 2018 our oldest home, Cherrybrook, began to have some small issues during inspections . . . new paint, new outlets, fixtures, flooring, etc., but only in a few random places. At the same time, there were issues with residents having to share bathrooms and bedrooms. So, everything combined, we began to discuss what the possibilities were to correct everything all at once.

Originally, we talked about being able to do the work ourselves for a pocket full of change and maybe a volunteer or two. Oh, and it was only going to take a month or less! For anyone who understands that our facilities fall under commercial property laws you'll understand how naïve we were! Even better, about that time we got in contact with The Sojourners. They are a group of mostly retired people who travel the nation helping places like ours to build and remodel and they wanted to help us. The Sojourners worked non-stop but, in the end, they could only stay a week and so what we accomplished was mostly cosmetic. With their help, we fixed a few things, laid new floor, painted and made everything look really nice. Cherrybrook would now pass inspections just fine but some issues were not able to be fixed. With thanks for what they had done, we began to make plans for the next summer when they would be available again but for a longer time period.

We started talking to all the right people. We got codes people and fire marshals and architects and contractors involved. We got quotes and estimates and promises and advice and more than a few "good luck's." We found out that we fell under commercial building codes and realized that our budget would need to be multiplied several times over and got Development involved in raising funds. What we originally thought could be accomplished for \$20,000 went up to \$80,000.

By the beginning of 2019 we had a newly completed architectural drawing that was everything we wanted. It had 8 bedrooms with full bathrooms in each. We had rearranged the layout in a way that would make supervision much more effective, including a full-sized laundry room, game room, and staff office in a centralized location.

After months of talking with different contractors and specialists we finally found Sam Lewis, of Lewis Construction, who was willing to supervise the project and to let us do any and all of the work we were capable of doing. Sam and his crew handled all of the plumbing and another company completed the AC work. Other than that, the bulk of the work came down to the staff at the east campus. Oh, and the Sojourners had to cancel (due to COVID-19 restrictions)? and all the extra help we imagined never came to fruition.

We began demolition at the beginning of September 2020. It happened incredibly fast. With the help of all the boys and staff we completely gutted that part of the house in 2 days!

It was also a long 4 months. All of the staff helped at times, and everyone sacrificed their time and effort to support everyone else. There were three men who were involved on a daily basis though: Joel Halsey, houseparent; Troy McCord, principal, and Richard Johnston, director. These three worked nearly every single day of those 4 months, doing whatever was necessary to get the job done. We worked with the residents because it was such an incredible opportunity for them to be a part of even though sometimes it was more stressful to include them. We learned or improved skills to a point that they would pass commercial-grade state inspections. In the end we were all so tired. But as we began the cleanup process there was an amazing sense of accomplishment and pride in what we had done. •





As a house parent and maintenance staff, what an awesome feeling to be a part of the wonderful transition that Cherrybrook went through. I know this project was a dream for a while because since I arrived on campus it was talked about often. The rooms in Cherrybrook, our relief home, limited us with the number of bedrooms and the bathrooms that had to be shared. When the time came to grab the sledgehammers and begin it was exciting. Walls and ceilings came down, everything came out of the back half of the home, and the dumpster, and garage, and any storage areas we had, began to fill up. Just after that the walls were going up and electrical and plumbing were being roughed in, things started taking shape. As the months passed the push to the completion was on and I began to hear questions from the staff about how far we were from finishing the project. The excitement was now building from them as they saw everything coming together. I had the pleasure of being in that house once again today and I am still amazed at what can be completed when minds and backs are put to the test. The finished product looks amazing, and we are so excited to have eight rooms with bathrooms, a laundry room, and an office all as they should be. To have been a part of this project and see it come together was a wonderful experience.

I'm not a contractor and I've never built a wall in my life! But I love designing and planning things. I got into woodworking years ago and I've got all the tools for the job. I remember turning conversations about what we wanted into the first real drawing of the new Cherrybrook. It was colorful and changed so much by the time it was all done that it's almost comical. In the end I got to watch everything we talked about be put in place and turn into something amazing!

I think one of the neatest things that we did during this project came later and again involved all of the boys and some of the staff. Somewhere in all of that new construction a time capsule is hidden. As a school assignment I had the boys write letters to themselves. The idea was for them to write a letter to their older selves, future family member, or just whoever was around when and if it is ever found. For some it was just a simple survey of what their favorite food/movie/memory, etc. was. Others took it to heart and wrote letters with advice and best wishes for their future selves. Even some of the staff participated. I don't know if it will ever be found or not, but I don't think that's the important part. What is important is the memories it evokes in those that were a part of the Cherrybrook project.

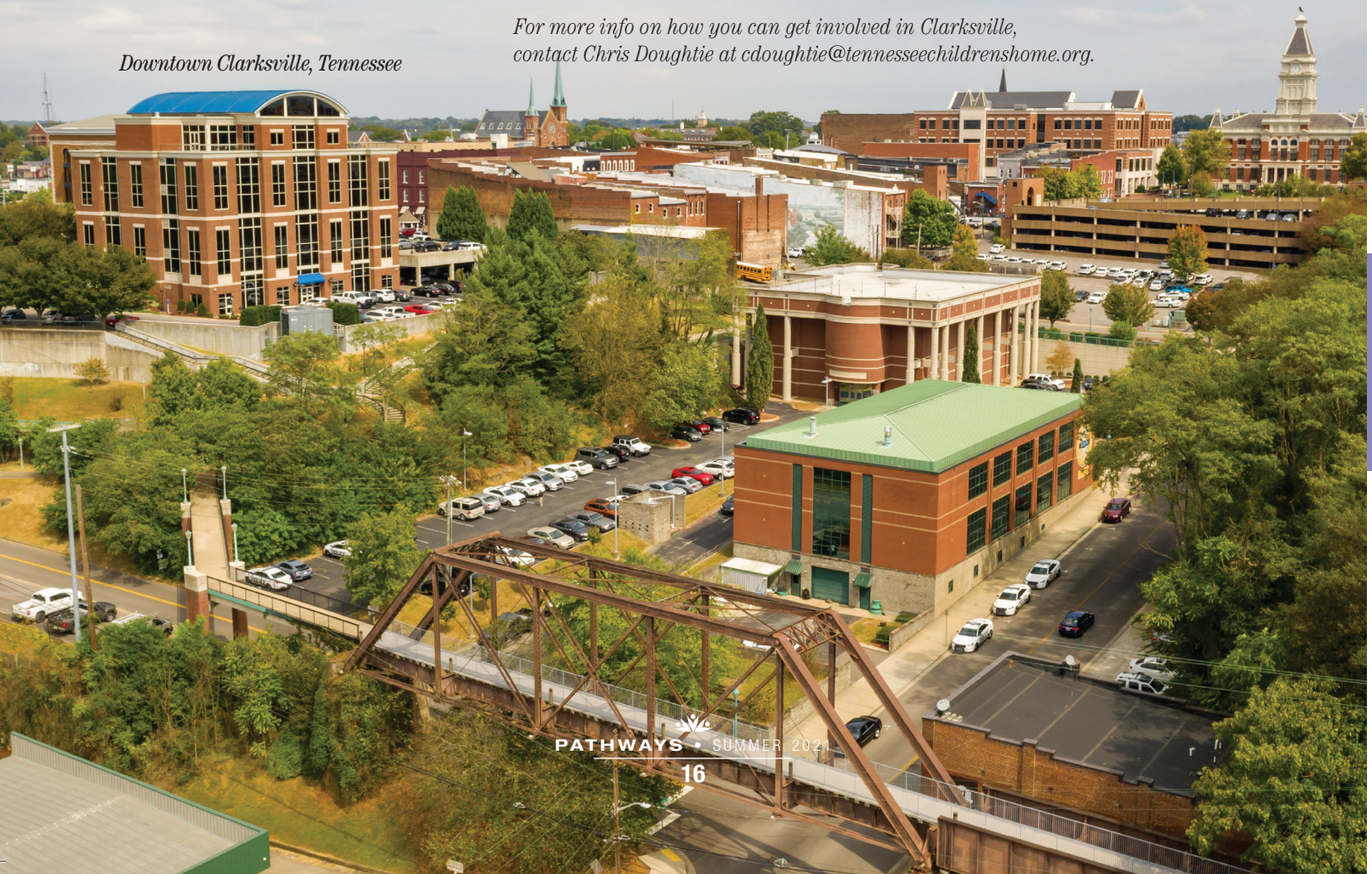
A Great Location

The North Central campus is now located in Clarksville, Tennessee. The 'new-to-us' apartments are three-bedroom townhomes with three young adults living in each apartment. At this time there are three young women and two young men in the *Independent Living program*. A displaced family will be moving into one of the apartments soon and will be the first family served at this location. It is a convenient area for the young adults in our programs, with bus stops, grocery stores, employment opportunities, and medical clinics all within walking distance. Three of our young adults are working at a Sonic nearby and another young lady has been employed by a daycare across the street from the apartments. The program has served 15 young adults since October 2018.

Meeting spiritual needs is important for the individuals served. Devotionals and Bible studies are conducted on campus for those who want to participate. Tennessee Children's Home is dedicated to helping these young adults and displaced families achieve their desired goals. •
